<u> 1. Title</u>

Comprehensive service of country risk information

2. Description of the service

All of the four services listed blow shall be offered.

(1) Reports

Reports of a total of more than 180 countries/regions are issued, of which all the 90 countries/regions indicated in the shaded cells in the annex-a table shall be reported. In addition, medium- to long-term outlook analysis of political situation, external relationship, economic situation, trade information, external debt on Venezuela and Cuba shall be reported.

The reports shall include the following information and be updated every month.

-Political situation

- Past political situation
- Latest and current political situation and outlook
- Constitution, political system, political party information, parliamentary composition, and key politician profiles
- External relationship and trends in armed forces
- Security information (dispute, terrorism and anti-government movement)

-Economic situation

- Latest and current economic situation and outlook
- Economic and fiscal policies
- Information on key industries and sectors (agriculture, mining, manufacturing, construction, and financial industries)
- Domestic energy situation, natural resources and development, and infrastructure
- Trade information (export and import of goods, and FDI inflow)
- Information on foreign reserves, external debt, and foreign exchange rate
- Relationship with IFIs and regional cooperative organizations

Reports shall be submitted via internet (online service). Past reports shall be made available too.

(2) Economic data

Economic data to be offered shall include the following information.

- 1 Economic data
 - -Economic information on more than 180 countries/regions (see the annex table)
 - -Annual data since 1980 till the present year and outlook for next five years
 - -Data shall be updated at least monthly. Monthly, quarterly and yearly data shall be submitted.
 - -Data shall include:
 - · GDP, per capita GDP, and real GDP growth rate
 - Fiscal and financial indicators(Fiscal balance, CPI, foreign exchange rate, interest rate, and external debt)
 - Balance of payments indicators (current account, foreign reserves, trade statistics, etc.)
 - Investment statistics
 - -Five year outlook on key commodities price such as oil and mineral resources
 - -Data shall be submitted electronically so that it can be processed using an excel and can be processed into a graph.

2 How to submit data

- -Internet online service
- -On CD-ROM (updated monthly)

(3) Risk rating

The following risk-rating information shall be offered Risk should be divided into at least five levels, including two-year outlook.

- -Security risk
- -Political stability
- -Political environment risk in business
- -Risk related to legal system and control
- -Risk related to macroeconomics
- -Risk concerning foreign trade and payments
- -Financial risk

- $-\mathrm{Risk}$ related to tax system
- Risk related to labor market

 m Risk}$ concerning infrastructure

The rating covers more than 180 countries listed on the annex table. It shall be updated at least three times a year and submitted online.

(4) Daily news reports

Analysis information of news and events shall be made and reported concerning each county's policy, economy, finance, and business. It should be available online and updated daily. The information offered in the past should be available also.

April 1, 2015 to March 31, 2018
